QUERY OVER GROSS VIOLATION OF THE CONSTITUTION, SET RULES AND DIRECTIVES OF THE AFRICAN ACTION CONGRESS.

A very warm season's greeting to you from the State's leadership of our great Party.

We are in receipt of three letters each dated 15th December, 2022; 19th December, 2022 and 26th December, 2022 respectively, which were referred to the leadership of the Party in the State by the Party's National Working Committee. Each of the letters were signed by you as "Chairman of the forum" of a so-called "AAC Governorship Candidates' forum" (see attached)

In the letter under reference, you issued threats and ultimatums to the Party's National Executive Committee/National Working Committee and also made inaccurate and highly mischievous narratives targeted at bringing the Party to hatred and dispute.

We were shocked to discover that none of the issues raised in the letters had been formally communicated to the State Executive Committee of the Party to which you are primarily responsible.

The so-called _"AAC governorship candidates' forum"_ is unknown to the Party and its constitution, and may be an attempt to undermine the Party and its organs including the Akwa Ibom State Executive Committee.

It is important to note that setting up parallel platforms that are unknown to the constitution of the Party is punishable under section 80 subsection 2 (b), (c), (d), and (e) of the AAC constitution.


Recall that the Party highest leadership had directed during a recent virtual meeting with all Party's candidates had directed that you jettison such unconstitutional endeavors and constrain your organizing within the constitutional and structural framework of the Party.

It however appears that you have willfully conspired with others to defy a directive by the National Chairman, during the meeting under reference, to comply with the constitution and organizational rules by sending more letters to the National Secretariat of the Party where you boldly stated your decision not to comply with the directives, organizational rules and constitutional provisions of the Party.

May we bring to your attention that such defiance and flagrant disobedience of constitutional organs of the Party does not only contravene section 10 (a) (b) and (c) of the constitution, it is also punishable under section 80 Sub-section 2 (b) (c) (d) (e) and (f) of the Party's constitution.

You are by this letter requested to respond to this query within 48 hours, to explain why disciplinary actions should not be taken against you for the infractions listed above.
